This cloud can move in unpredictable directions due to the light variable

higher rated flows produce larger droplets. PRESSLIRE — Do not exceed the nozzle manufacturer's recommended pressures. For many nozzle

types lower pressure produces larger droplets. When higher flow rates are needed, use higher flow rate nozzles instead of increasing pressure. NUMBER OF NOZZI ES — Use the minimum number of nozzles that provide uniform coverage.

. VOLUME - Use high flow rate nozzles to apply the highest practical spray volume. Nozzles with

- . NOZZLE ORIENTATION Orienting nozzles so that the spray is released parallel to the airstream produces larger droplets than other orientations and is the recommended practice. Significant deflection from horizontal will reduce droplet size and increase drift notential.
- NOZZLE TYPE Use a nozzle type that is designed for the intended application. With most nozzle types, narrower spray angles produce larger droplets, Consider using low-drift nozzles, Solid stream nozzles oriented straight back produce the largest droplets and the lowest drift.

BOOM LENGTH: For some use natterns, reducing the effective boom length to less than 36 of the wingspar or rotor length may further reduce drift without reducing swath width. APPLICATION HEIGHT: Applications should not be made at a height greater than 10 feet above the top of

the largest plants unless a greater height is required for aircraft safety. Making applications at the lowes height that is safe reduces exposure of droplets to evaporation and wind. SWATH AD ILISTMENT: When applications are made with a crosswind, the swath will be displaced downwind. Therefore, on the un and downside edges for the field, the applicator must compensate to
